RELEASE OF LIABILITY

IN CONSIDERATION FOR BEING PERMITTED BY THE TEXAS BOSTON TERRIER RESCUE, INC. ("TBTR") TO PARTICIPATE AS A VOLUNTEER IN VARIOUS ACTIVITIES, I HEREBY WAIVE, RELEASE, AND DISCHARGE ANY AND ALL CLAIMS AND DAMAGES FOR PERSONAL INJURY, DEATH, AND/OR PROPERTY DAMAGE WHICH I MAY SUSTAIN OR MAY WHICH HEREAFTER ACCRUE AS A RESULT OF MY PARTICIPATION AS A VOLUNTEER AND RESULTING FROM NEGLIGENCE OR MISCONDUCT OF TBTR. THIS RELEASE IS INTENDED TO DISCHARGE IN ADVANCE THE TBTR, ITS DIRECTORS, OFFICERS, AND/OR AGENTS TO INCLUDE THEIR HEIRS, AGENTS, REPRESENTATIVES, SUCCESSORS AND ASSIGNEES FROM AND AGAINST ANY AND ALL LIABILITIES, ACTIONS, CLAIMS, DEMANDS, COSTS, OR EXPENSES ARISING FROM OR IN ANY WAY CONNECTED WITH MY PARTICIPATION AS A VOLUNTEER AND RESULTING FROM THE NEGLIGENCE OR GROSS NEGLIGENCE OF TBTR. I UNDERSTAND THAT VARIOUS ACTIVITIES INVOLVING DOGS CAN BE HAZARDOUS IN NATURE, INCLUDING BUT NOT LIMITED TO BEING EXPOSED TO DISEASES THAT CAN BE TRANSMITTED FROM ANIMALS TO HUMANS AND THE POSSIBILITY OF BEING BITTEN, SCRATCHED, JUMPED ON OR KNOCKED OVER. THE POSSIBILITY OF SERIOUS ACCIDENTS AND/OR INJURY CAN OCCUR DURING PARTICIPATION IN VOLUNTEER ACTIVITIES. KNOWING THE RISKS INVOLVED NEVERTHELESS, I HAVE VOLUNTARILY APPLIED TO PARTICIPATE IN VOLUNTEER ACTIVITIES AND I HEREBY AGREE TO ASSUME ALL RISKS OF INJURY, AND TO RELEASE AND HOLD HARMLESS THE TBTR, ITS DIRECTORS, OFFICERS, AND/OR AGENTS WHO THROUGH NEGLIGENT OR CARELESSNESS MIGHT OTHERWISE BE LIABLE TO ME.
